Andrew McIlvaine presented a preliminary 2012-13 budget to the Board and members of the public.

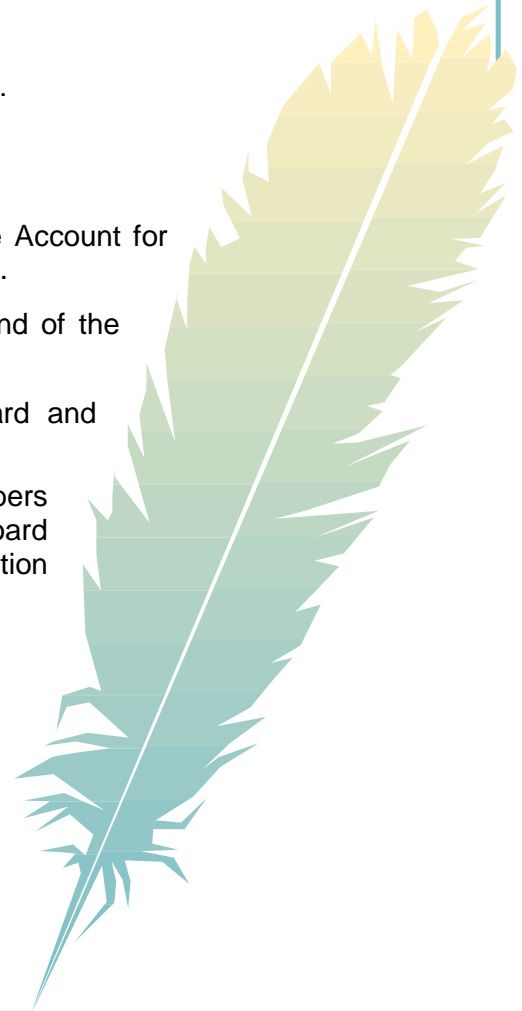
